2017 JOINT ANNUAL MEETING AND SUPERVISOR ELECTION IS SEPTEMBER 12TH!

Stark Soil and Water Conservation District (SWCD) and Stark County Farm Bureau will hold a joint annual meeting at Varian Orchards in East Canton on Tuesday, September 12, 2017. The doors open at 6:00 p.m. with dinner served at 6:45 p.m. The joint business meeting starts at 7:30 p.m. and ends at 8:30 p.m.

Stark SWCD will hold an Election of Supervisors at the meeting for two positions on the Board of Supervisors for three year terms that begin on January 1, 2018. Voting begins at 6:00 p.m. and ends at 7:00 p.m. The SWCD Nominating Committee placed the following candidates on the ballot for the two available positions:

Individuals interested in petitioning to be on the ballot must submit completed petitions to the SWCD office by 4:30p.m. on August 8, 2017.

Ballots must be returned to the SWCD office no later than 4:30p.m. on September 12, 2017. To vote in the election, you must be a Stark County landowner or resident and be over 18 years of age.

Tickets are \$15 per person for Farm Bureau or SWCD members and \$30 for non-members.

Programs	Program Topics
Soil	Testing soil for essential nutrients, determine soil composition, soil typing, creating sediment, soil layers, decomposers, composting, weathering and erosion, living and non-living parts of soil, reading soil maps
Water	Determine water quality based on macroinvertebrates (go to stream, bring to program, or use a model), storm water, water cycle, weathering and erosion
Natural Resources	Ecosystems, biodiversity, nutrient cycling, invasive species, farm to school, species interactions, point-source and non-point source pollution, recycling, composting, waste, energy transfer, photosynthesis, populations, continuation of species, genetic modifications, algal blooms, etc.
Outdoor Learning	Identifying living and non-living organisms, habitats, niches, locating and observing organisms around the school, testing school soil
Teacher Workshops	Project WET, Project WILD, soil, water quality monitoring, outdoor learning spaces, education grants
Clubs/Organizations	Composting, rain barrels, outdoor learning spaces, best management practices, pollinators, native species, water quality

Feds and Farming

"I don't want the government to have anything to do with my farming operation," a local producer relayed to me this month. I can understand his mistrust, I have, after all, worked in the federal government for 34 years. A lot has changed in those 34 years for sure. More laws and programs from the government side, and more yields, equipment and efficiency on the farm side. And don't forget the advances in science and technology for everyone. But one thing is the same, participation in USDA programs is voluntary. A lot of people have worked hard and long to keep it that way.

That is one reason our wetland rules are different than EPA's. EPA enforces federal regulations period. USDA "enforces" Farm Bill regulations only for individuals and entities that participate in Farm Bill programs. I realize that some of the programs are an economic necessity for many operations, at least sometimes like during droughts or disasters, so the voluntary concept may be debated. Even so, your local conservationists still have the mindset that we are here to help you. Help you plan, help you improve your land for your family, and all that depends on healthy soil and water.

Our assistance is designed to help you make the best decisions for your operation. You are the decision maker. We help you formulate alternatives to solve any resource concerns, whether that is soil, water, air, plants, animal, or human concerns such as labor, time, or capital. We do it with science, engineering, financial assistance, and a true desire to help you help the land. In NRCS we can provide just technical help, or both technical and financial assistance through governmental contracts. Contracts do require commitment, the key is to make good decisions through planning. The plan that documents your decisions is the basis for the contract if you are selected for funding.

Good planning takes time. Now is a good time to start the planning process for the next few years, if you want to compete for funds this fall which will be fiscal year 2018. You can call our office at 330-830-7700 ext. 103 to set up an appointment to meet with a conservationist. Remember, you are the decision maker.

Unless extended, this will be the last year of programs for the 2014 Farm Bill. What will the 2018 Farm Bill bring? Well, you can voluntarily influence that as well.
